ISEAL Code of Good Practice

The ISEAL Code of Good Practice is a normative reference that operationalises the ISEAL Credibility Principles.

The Code defines **credible management** of the components **of a sustainability system**, including standard-setting, assurance, claims, and impacts (monitoring, evaluation, and learning).

"Due diligence is the process enterprises should carry out to **identify, prevent, mitigate and account for how they address the actual and potential adverse impacts of their activities on people and the environment**. These impacts can be in their own operations, their supply chain or as part of other business relationships."

Due diligence as an evolving concept

- Due diligence laws establish a legal floor requiring companies to address risks and negative impacts
- All due diligence frameworks require some type of process for identifying and managing risks in operation and supply chains
- Due diligence as a process of continuous improvement VS a market obligation
- From mandatory disclosure and reporting to **'full responsibility' across supply chains**

Increasing role for voluntary systems/standards, certification, industry initiatives

But these cannot 'remove' the responsibilities of companies



Driving effective and impactful corporate due diligence

We want companies to use sustainability systems as tools to implement **effective, fair and impactful due diligence** processes.

This means;

- (i) working towards **better alignment** and **interoperability** between due diligence regulations and sustainability systems
- (ii) Strengthening organisational policies of sustainability systems in line with emerging due diligence expectations and regulations



Sustainability systems and standards as due diligence tools – existing and potential roles

- Provide reliable and actionable data and information about risks, mitigation, and remediation to supply chain actors
- Go above and beyond mandatory minimum to drive more ambitious and holistic impacts
- Creating sector-wide consistency and transparency in applying and assessing sustainability risks and impacts
- Enable collective action and drive implementation partnerships

Due diligence in the draft Code

The Code aims to:

> address the scheme's own responsibilities

> enable the scheme in defining the role it intends to play in corporate due diligence efforts.

> provide a framework to include due diligence in the scheme's operations

The strategy to achieve this is:

> a more holistic approach to the responsibilities of a sustainability system

introducing clauses with direct reference to due diligence or due diligence related activities





for Responsible Business Conduct

Code requirements

Requirements focused on strengthening the ability of systems to support effective due diligence are within chapters 1, 2, 5 & 8

1.2	Strategy for impact	Analysis informing focus	The scheme makes informed decisions about how to focus its work.
2.6	Scheme governance, operations, and integrity		The scheme owner uses contractual measures to manage risks to the integrity of its scheme.

5.7			The scheme has impartial and accessible mechanisms in place for resolving complaints and conflicts.
